The unit Approval Committee perused the letter dt.22.03.2017 of the Company that Shri Srinivasa Satya Ragnath Chowadar emmani, one of the two Directors of the proposed Unit, which stated that the Director resides in Germany and is an Indian National and does not have taxable income in India.

The Unit Approval Committee after deliberations deferred the proposal and asked the Company to submit documentary proof to the effect that Shri Srinivasa Satya Ragnath Chowdary emmani did not have taxable income in India and a certificate from I.T. authorities that he is not an income tax assessee in India. And, they are also to submit the details of source of finance for their investment for their proposed Project.

Proposal of **M/s. Yamyah IT Services Pvt.
