The Approval Committee clarified that services approved under Notification 12 are deemed to be approved under Notification 7/2014 as the later is only clarificatory in nature. Hence separate approval under 7/2014 is not required.

The following are the reasons for adopting higher values on BOM proposal of each building.

- 1. At the time of Initial stage they took the BOM Approvals with Supply, Installation and Commissioning as the values includes cost of materials and services.
- 2. They took the Approval for the goods such as Batching Plant, Tower Cranes, Concrete Pumps, Scaffolding Material, TestingEquipmentsetc for each building. But in practice they have not purchased the same for each building. They have purchased only one Batching plant and two tower cranes. The remaining materials were procured by the contractors without any SEZ benefits. Further one time purchase will be sufficient for entire project of 5 buildings in as much as each building is being constructed one after another.
- 3. In all above buildings they have not done the interior works which required high value items of interior decoration items including furniture. The interior cost is about Rs ---- lakhs for sq. ft/sq. Meter. Accordingly, taking these costs in consideration they have estimated the cost of each building at higher side as shown in the BOM Proposals. Infacttheir client on their own did /have done interior work.
- 4. The value mentioned under column no 4 are actual consumption of the BOM for each building.

The Approval Committee discussed and **noted**the consumption subject to verification of the above utilization particulars by the Specified Officer.
