- 4) The rate quoted should remain valid for a period of 60 days from the date of opening of quotations.
- 5) The items should be strictly confirmed to the specifications prescribed. Items not confirming to the specifications shall not be accepted. The work shall be carried out as per the directions of Secretary i/c of VSEZ Authority.
- 6) The party/parties whose rates are accepted by this office shall have to carry out the work within a period of 30 days from the date of receipt of supply order/work order from this office.
- 7) No amendments of alterations in the rate quotation once offered shall be allowed after opening.
- 8) The Development Commissioner reserves all the rights to accept or reject any or all the rate quotations without assigning any reasons thereof.
- 9) The Contractor should make his own arrangement for Water Supply and T&P etc.
- 10) The payment shall be made as per actual quantities executed at site of work after deducting applicable taxes from the bill.
- 11) The quantities are tentative and likely to vary and also the rates quoted shall be applicable for varied quantities.
