SUPPLY "STEAM" GENERATED FROM CLEAN ENERGY SOURCE TO DTA UNIT – REG.**

M/S. DR. REDDY'S LABORATORIES LTD., A SECTOR SPECIFIC SEZ FOR PHARMACEUTICALS HAS INFORMED THAT AS PART OF THE AUTHORIZED OPERATION, THEY HAD SET UP A 10 TPH CAPACITY BOILER FOR GENERATION OF STEAM FOR SUPPLY OF THE SAME TO THE UNITS IN THE SEZ AND SOME FACILITIES OF DEVELOPER ALSO. IN HIS CONNECTION, THEY HAVE SUBMITTED THAT, KEEPING IN VIEW OF THE FUTURE REQUIREMENTS THEY HAVE INSTALLED A HIGHER CAPACITY BOILER IN THE SEZ. NOW THEY HAVE OBSERVED THAT THE BOILER IS REQUIRED TO BE RUN AT THE INSTALLED CAPACITY FOR SMOOTH FUNCTIONING OF THE EQUIPMENT AND QUANTITY EMISSION WHERE AS THE STEAM REQUIREMENT OF THE TWO UNITS IN THE ZONE IS ONLY 2 TPH WHEREAS IF THE BOILER IS RUN AT THE INSTALLED CAPACITY THE TOTAL STEAM GENERATION WILL BE 10 TPH AND THE REQUIREMENT IS 2 TPH AND THE REMAINING 8TPH STEAM WILL BE WASTE. TO AVOID WASTAGE OF THE SURPLUS STEAM THE DEVELOPER HAS PROPOSED TO SUPPLY THE STEAM TO THEIR UNITS LOCATED IN DTA AND REQUESTED FOR NECESSARY PERMISSION TO SUPPLY THE STEAM TO THEIR DTA UNITS ON PAYMENT OF APPLICABLE DUTIES.

AS PER THE PROVISION OF SEZ RULES ANY GOODS/SERVICES SHALL BE CLEARED ON PAYMENT OF APPLICABLE DUTIES. IN THE INSTANT CASE AS PER THE INFORMATION ASCERTAINED THERE IS NO DUTY ON BOTH INPUTS (RICE HUSK) AND OUTPUT (STEAM). SINCE THERE ARE NO CLEAR PROVISIONS IN THE SEZ RULES FOR CONSIDERING THE REQUEST OF THE DEVELOPER THE PROPOSAL IS PLACED BEFORE UAC FOR NECESSARY CONSIDERATION.
