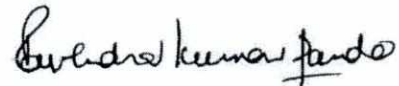
The proposal was discussed and instructed the applicant to furnish revised details for further Consideration of the proposal.

AGENDA Item No: 3:

Proposal of M/s. Vayhan Coffee Ltd., an EOU at Sy. No., 141 and 142, Garlamadugu Village, Pedavegi Mandal, West Godavari District holding Letter of Permission for manufacture of "Instant Coffee" at an annual capacity of 3600 MT requested for permission to import 'instant coffee powder' to manufacture 'instant coffee' (agglomerated form).

The proposal of the unit to import 'instant coffee powder' was discussed at length. It was decided to write to DoC, New Delhi for a clarification as to whether the unit can be permitted to import 'instant coffee powder' since the unit's one of the finished products under their Letter of Permission also happens to be 'instant coffee powder' and if permitted to import the same it may amount to 'Trading' under EOU Scheme.
