

Sl. No. 14. M/s. Naturol Bio Energy Ltd unit was found to be Negative NFE status and the unit requested for exit from the EOU scheme. The in-principle exit granted to the unit on 12.09.2013 which has expired on 11.03.2014 as prescribed in Appendix 14-I-L of Hand Book of Procedures. No application for extension of in-principle approval is received and in the meantime the unit had submitted the APRs and requested the office to condone the delay in submission of NDC. The Committee decided to grant fresh in principle exit permission to facilitate easy exit from EOU as desired by the applicant.
