They also made reference to their representation dated 24.12.2010 submitted to the Commerce Secretary seeking exemption from NFE earning obligation.

The Committee opined that Unit Approval can be accorded subject to provisions of Section 2 (z) of the SEZ Act 2005 and fulfillment of NFE earning obligation under Rule 53 of the SEZ Rules 2006. IWMUSL was, however, advised to re-consider setting up the facility as a Co-Developer instead of as a SEZ Unit in which case there would no NFE earning obligation.
