Agenda items No.3

Request of M/s.Akrivis Health Care Pvt.Ltd., VSEZ for incorporation of 'Gloves' (Latex, Mitrile, Vinyl) in their existing LoA for trading under broad banding-reg.

The Unit was issued LoA dt.10.12.2020 for trading activity in 'Personal Protective Equipment (PPEs) except gloves and Medical Equipment and supplies'.

The unit now requested for inclusion of 'Gloves' (Latex, Mitrile, Vinyl) in their existing LoA for trading under broad banding.

Earlier the item 'Gloves' was not allowed by UAC as the item was under restricted category. Now DGFT vide Notfn. No.47/2015-20 dt.22.12.2020 change the category to "Free".

The unit submitted requirement of trading material, components etc., to the tune of Rs.49.25 lakh and Rs.147.74 lakh both imported and indigenous for the next 5 years and FoB value of Exports for 5 years to the tune of Rs.787.88 lakh. and Foreign exchange outgo to the tune of Rs.49.24 lak and NFE to the tune of Rs.738.64 lakh.

The unit has not submitted/executed the BLUT yet for accepting the conditions of BLUT and thereby binding themselves of the conditions to enable them avail of the duty exemptions available to them on imports and procurements on execution of the BLUT.

The unit has not completed the process for starting their operations yet by submitting/ execution and acceptance of BLUT by this office in respect of their LoA dt., 10.12.2020..
