M/s Glaukos Algae Technologies Private Limited vide application dated 10.05.2021 received in this office on 31.05.2021 has submitted an application for conversion of their existing DTA into EOU located at Plot Field S.No.469-B, East Gogupalle Village Post (Vil No.13) Alluru Mandal, Potti Sriramulu Nellore District, A.P for manufacture of 'Dunaliella Saline (DS)-Marine Micro Algae (Algae based beta Carotene/Biomass)'.

Applicant has furnished the application in ANF- 6A along with DD of Rs. 5000/-towards application fees.

It has been informed in the application that product proposed to be manufacture in EOU falls under ITC HS code of Chapter Heading 32 (32030090). The unit has submitted that they have imported Capital goods worth Rs.2.30 Crores under EPCG scheme. Further the unit has indicated that their EPCG obligation is 492.99 Lakhs. It is reported that the capital goods imported by the unit has not been installed in the company.

The unit has submitted that they have established an exclusive company for the cultivation and processing of Marine Micro Algae at Nellore in an area of 10 acres. M/s Glaukos Algae Technologies Private Limited is incorporated on 05.08.2019. Initially they have started their project in DTA and later they have decided to convert the DTA to EOU by subsuming the imported Capital goods against EPCG. As a newly incorporated company, the unit has submitted that there is no existing capital structure and they have not made any exports. The unit has submitted photographs of the existing project.

In terms of para 6.07(d) of FTP .2015-20 which states that 'Applications for conversion into an EOU/EHTP/STPI/BTP unit from existing DTA unit, having an investment of Rs.50 Crores and above in plant and machinery or exporting Rs.50 Crores and above annually, shall be placed before BOA for a decision.

In the instant case, investment of the unit is less than 50 crores (22.60 Crores) and annual projected exports is more than 50 Crores.

Criteria to be adopted for Automatic approval of units under EOU Scheme in terms of Appendix 6A of Hand Book of Procedures, 2015-20

Policy Provision (FTP-2015-20)

In terms of para 6.06 of Foreign Trade Policy, 2015-20, the Criteria of a minimum investment of Rs. 1.00 Crore on plant and machinery prescribed for setting up of EOU is complied with in this proposal.

The present proposal does not fall under the category of requirement of Industrial license under I (D&R) Act, 1951.

The proposed product i.e Dunaliella Salina (DS)-Marine Micro Algea (Algae based beta Carotene/Biomass) has been verified from the prohibited list of items under Wild Life Protection Act,1972 under Export Policy of DGFT, DOC and the same is not listed under the same. In this context, the unit has also submitted NOC copy dated 01.07.2020 from National Biodiversity Authority.

The request of M/s Glaukos Algae Technologies Private Limited located at Plot Field S.No.469-B.East Gogupalle Village Po(Vil No.13) Alluru mandal, Potti Sriramulu Nellore District, A.P for manufacturing and Export of Dunaliella Salina (DS)-Marine Micro

Algae(Algae based beta Carotene/Biomass)' is submitted before UAC in terms of Para 6.01 read with Para 6.32 of HBP, 2015-20, please.

Agenda item No.2: Proposal of M/s. Kaleesuwari Refinery and Industry Pvt. Ltd-Reg.

Revised proposal of M/s.Kaleesuwari Refinery and Industry Pvt.Ltd., for starting operations for manufacture of 'Bio-diesel' and Crude Glycerin (by product) by importing alternate raw material i.e., Pal Acid Oil (HSN 38231900) and Spent Earth Oil (HSN 15159010) instead of Used Cooking Oil – Request for revival of the LoP No.PER/480/EOU/VSEZ/2019 dt.30.8.2019 and extension of the same in terms of para 6.01(b)(ii) of HBP 2015-20 by Development Commissioner, VSEZ

The LoP was actually withdrawn by the office of DC, VSEZ, vide letter dt.08.11.2019, till further orders consequent upon rejection of the proposal of the Unit for import of Used Cooking Oil, a prohibited item, for manufacture of 'Bio diesel and its by product glycerin, .by BoA, New Delhi - vide minutes of the meeting of BoA held on 4.10.2019.

The unit has in their letter above letter stated the following for consideration by the UAC:

- that a few suppliers including M/s.British Petroleum, with whom they had buyback agreement for export of biodiesel has approached them for supplying them alternate raw material viz., 1. Palm Acid Oil HSN 38231900 and 2. Spent Earth Oil HSN No.15159010 both stated to be free for import for manufacture of Bio diesel under buy-back agreement.
- that all the imported raw material will be manufactured into Biodiesel (with Glycerin as By-product coming out of the manufacturing process) and exported back after conversion of the same into Biodiesel as per the agreement.
- That they have implemented stringent internal controls with respect to the movement of imported raw material. by-product and finished goods within the premises with installation of CCTV camera, maintenance of stock registers and submission of monthly and quarterly returns to the jurisdictional customs authorities, to ensure there is end- to-end utilization of the imported raw material.
- That the written down value of Capital goods to be included part of EOU is Rs.10.14 crore (and submitted CE certificate for the same) and expected turnover from the EOU for the 5 year period is Rs.1500 cr.
- Submitted brief write up with respect to the proposed contract for supply of Bio diesel
- Revised projections along with projected balance sheet, showing Exports for the 5 year period as Rs.151423.00 lakh and NFE earnings for the 5 year period as Rs.36,623.00lakh

In this regard, the following are submitted to the UAC for kind attention:

- M/s.Kaleesuwari Refinery was earlier functioned as M/s.Natual Bio-Energy Ltd., under EOU scheme. They had switched over to EPCG scheme from the EOU scheme with an additional export obligation for the negative NFE in the EOU scheme to the EPCG scheme granted by the PRC. DGFT, New Delhi on their application for the same.
- The representation of the unit for manufacture of Bio-diesel with the imported UCO with certain additional conditions was forwarded to DoC vide letter dt.23.12.2019 by this office for re-consideration. The reply from DoC is still awaited.
- The HSN nos. declared by the Unit for alternate raw material ie., Pal Acid Oil (HSN 38231900) and Spent Earth Oil (HSN 15159010) may be discussed for confirmation of the same by the UAC.

Policy provision:

"On approval, a Letter of Permission (LoP) shall be issued by DC / designated officer to EOU unit. LoP shall have an initial validity of 2 years to enable the Unit to construct the plant & install the machinery and by this time the unit should have commenced production. In case the unit is not able to commence production in initial validity of 2 years, an extension of one year may be given by the DC for valid reasons to be recorded in writing. Subsequent extension of one year may be given by the Unit Approval Committee subject to condition that two thirds of activities including construction, relating to the setting up of the Unit are complete and Chartered Engineer's certificate to this effect is submitted by the Unit. Further extension, if necessary, will be granted by the Board of Approval. Once unit commences production, LoP / LoI issued shall be valid for a period of 5 years for its activities. This period may be extended further by DC for a period of 5 years at a time"

The revised proposal of the Unit for manufacture of Bio-diesel and glycerin as by product with alternate raw material as stated above for revival of the LoP and simultaneously extending the same up to 31.08.2021 is placed before UAC, please.
