Agenda item No. 2

The Proposal of M/s Kaleeswari Refinery and Industry Pvt Ltd, for partial conversion of their existing DTA unit at Kakinada, AP into an EOI for manufacture and export of Bio-diesel with Glycerine as by-product has been discussed in the backdrop of conditional LoP dt 8.10.2021 issued in-principle by O/o DC, VSEZ subject to ratification by the UAC (i) to ensure that the proposed export by the unit is for non-fuel purposes only in line with the Trade Notice No 44/2018-19 dt.31.3.2019 issued by DGFT (ii) to get the confirmation as to whether full quantity of Capital goods that has been under EPCG scheme would be transferred to the proposed EOI etc. as desired by the O/o Addl DGFT, Hyderabad vide their letter dated 21.12.2021.

The UAC discussed the matter and decided that (i) to write to Jurisdictional Custom authorities, w.r.t. the inspection report dt 06.10.2021 furnished by them to confirm whether total capital goods that is under EPCG scheme are being converted into EOI and in place in the earmarked premises of the proposed EOI and (ii) O/o Addl DGFT, Hyderabad will take up the matter with DGFT Head Quarters with regard to as to how the proposed Bio-diesel once exported by the Unit is ensured to be used for non-fuel purposes as per Trade Notice No 44/2018-19 dt.31.01.2019. It has been further decided by the UAC that the in-principle Conditional LoP dt.8.10.2021 issued to the unit is kept on hold till further orders.
