
Ratification of minutes of the meeting held on 10.01.2022

The Proposal of M/s Kaleesuwar Refinery and Industry Pvt Ltd. for partial conversion of their existing DTA unit under EPCG obligation at Kakinada, AP into an EOU for manufacture of Bio-diesel with crude glycerin as a by-product was discussed in the light of the approval of Competent Authority, DGFT, New Delhi vide letter No.01/89/189/01/AM-19/PC-2(A)/Part-I/E-12785/371 dt.13.01.2022 (copy enclosed) for import of Prohibited item (Used Cooking Oil -ITCHS 15180040) by M/s Kaleesuwar Refinery and Industry Pvt. Ltd. for manufacture and export of Biodiesel with certain conditions

The UAC after deliberations observed that proposed export of Bio-diesel is apparently for fuel purposes and desired that (i) to ask the Unit to submit the Contract signed

by them with British Petroleum Singapore Pvt. Ltd . at the earliest, and (ii) to write a suitable letter to the Director (EOU), Department of Commerce, New Delhi after examining the Contract between the Unit and BPSP Ltd., as export of Bio-diesel for fuel purposes requires approval of BoA (DoC) in terms of Trade Notice No.44 dt.31.1.2019 issued by DGFT read with Para 6.01(a) and (b) of Foreign Trade Policy.
