At the outset, the Development Commissioner, VSEZ and Chairman, Approval Committee welcomed the participants. After a brief introduction, each items included in the agenda were taken up and after deliberations, the following decisions were taken:

Item No. 1: Ratification of Minutes of the UAC meeting held on 25.10.2022

The Approval Committee ratified the minutes of the UAC meeting held on 25.10.2022

Proposal for change in area of the SEZ units:

<u>Item No. 2 (a):</u> Proposal of M/s. Accenture Solutions Pvt. Ltd (u-4) in M/s. Lanco Hills Technology Park Pvt. Ltd, IT/ITES SEZ at Manikonda Village, Rajendra Nagar Mandal, Ranga Reddy District, Telangana for surrender of Incubation Space of their SEZ unit.

The Approval Committee after due deliberations, considered and approved the proposal for vacation of Incubation Space in an area of 76,531 sq. ft. in Ground to 2nd Floors in the above SEZ. After deletion of the same, the unit will be operational in an area of 2,00,735 sq. ft. on Ground Floor to 6th Floor, in the North Wing of Block B2 in the above SEZ.

<u>Item No. 2 (b):</u> Proposal of M/s. Sutherland Global Services Pvt. Ltd, unit in M/s. Lanco Hills Technology Park Pvt. Ltd, SEZ for IT/ITES at Manikonda Village, Rajendra Nagar Mandal, Ranga Reddy District, Telangana for temporary usage of space for training purpose for an extended period of 3 months for their SEZ unit.



The Approval Committee after due deliberations, considered and approved the proposal for temporary usage of space of 5,000 sq. ft. for a period of 3 months w.e.f. 1.10.2022 to 31.12.2022.

<u>Item No. 2 (c):</u> Proposal of M/s. GAP IT Services Pvt. Ltd, unit in M/s. TSIIC Ltd, SEZ for IT/ITES at Nanakramguda Village, Serilingampally Mandal, Ranga Reddy District, Telangana for surrender of partial space of their SEZ unit.

The Approval Committee after due deliberations, considered and approved the proposal for surrender of partial space of an area of 24,896 sq. ft. in Level 1A of Phase 2.3 in the above SEZ. After surrender of the same, the unit will be operational in an area of 93,939 sq. ft. in different levels in M/s. TSI Business Parks (Hyderabad) Pvt. Ltd, Co-Developer in the above SEZ.
