Brief Details of Project Profile furnished by the applicant:

M/s Sri Ganga Stone exports is a proprietary concern established by Sri Goineni Nagaiah who has been working as Head of Operations since 2009 as DTA unit in Granite manufacturing unit. The management of the firm is being managed by experienced persons for more than 15 years of experience in Granite Industry. Present proposal is for establishment of Granite Cutting & polishing unit for manufacturing of Granite Slabs/ Tiles by installing one multi wire saw machine , one Line polishing machine, Bridge cutting machine and one Gantry Crane for lifting raw block and other required machinery. They are importing advance Technology i.e multi wire granite cutting machine with the production capacity around 15000 Sqft per month with less wastage.

In terms of para 6.06 of Foreign Trade Policy, 2015-20, the Criteria of a minimum investment of Rs. 1.00 Crore on plant and machinery prescribed for setting up of EOU is complied with in this proposal.

<u>The present proposal does not fall under the category of requirement of Industrial license</u> under I (D&R) Act, 1951.

The request of M/s Sri Ganga Stone exports for conversion of existing DTA under EPCG obligation into EOU scheme for manufacturing and Export of "Polished Granite Slabs & Tiles is placed before UAC in terms of Para 6.19 of FTP, 2015-20 read with Para 6.01 and 6.32 of HBP, 2015-20 for consideration.

Proposal of M/s. Kaleesuwari Refinery and Industry Pvt.Ltd., -100% EOU- Sale of Bio-diesel in DTA to Oil manufacturing Companies (IOCL, BPCL, HPCL) underNational Blending Program-Reg

- 1. M/s.Kalesuwari Refinery & Industry Pvt.Ltd.,100% EOU was issued LoP dt. 30.08.2019 by this office partially converting their DTA unit with EPCG obligation into an EOU with the approval of UAC. It is pertinent to mention that PRC, DGFT had relaxed the condition for the manufacture of Bio-diesel and its by-product, Crude glycerin from Used Cooking Oil (UCO), a prohibited item for import and export of the above manufactured Bio-diesel. Further, the condition was to export exclusively to M/s British Petroleum as per the agreement between them with certain conditions put by O/o DGFT (copies enclosed)
- The unit vide their letter dt.20.01.2023 informed that they had obtained Letter of Intent for supply of Bio-diesel manufactured from Non-UCO feed stock sourced indigenously under National Blending programme to Oil Marketing Companies such as Indian Oil Corporation Ltd., Bharat PetroleumCorporation Ltd., and Hindustan Petroleum Corporation Ltd., to participate in the OMC Tenders(copy enclosed)
- 3. As per para 4(ii) of Trade Notice No.44 dt.31.01.2019 issued by DGFT, the feed stock for production of bio-fuel for export by an EOU should be from imported sources. They are not allowed to export Bio-fuels if the feed stock is from indigenous sources.

- 4. M/s.Kaleesuwari proposes to procure indigenous feed stock for production of Bio-fuel in the EOU plant for supply in Domestic Tariff Area to Oil marketing companies under National Blending programme .The above proposal is a pure DTA activity/operation.
- 5. The request of the Unit for production of **Bio-diesel from indigenous feed stock to supply in DTA to IOCL, BPCL, HPCL under the National Blending Program** was placed in the UAC meeting held on 14.11.2022. The Committee concluded that the Unit may approach the PRC for such issues and advised the Unit to take permission for activities beyond the purview of the LOP

However, as per directions, the EOU's request is again placed before UAC to discusson the request of M/s.Kaleesuwari , a EOU unit, to undertake DTA (Domestic Tariff Area) activities/operations paralelly in their EOU plant i.e., for manufacturing Bio-diesel from non-UCO material procured domestically and supply the same to Domestic Oil companies under National Blending programme.
