M/s Pfizer Heathcare India Pvt Ltd, unit in Visakha Pharamacity Ltd SEZ vide letter dated 12.12.23 has submitted a proposal for expansion/enhancement of capacity and procurement of additional Machinery and construction of plant with Warehouse.

The unit has been advised to submit separate proposals of expansion, enhancement of capacity of production and inclusion of additional products. Unit vide ltr dated 22.12.23 has clarified that they are going for expansion of capacity and will apply for drug licence later before the production.

The proposal for capacity expansion involving plant & machinery and civil construction works as indicated by the unit is as below:

Unit has mentioned that they are in operation for the last Eight years and the demand is increasing for the products manufactured in their SEZ unit. As the production levels are increasing, their management has decided to enhance the production capacity with modifications to the existing Blocks and construction of additional warehouse space with machinery for additional line for meeting the requirement. The unit has submitted detailed proposal with following requirements . An investment of Rs. 653.00 crores have been proposed for the additional line as part of enhancement of production with an additional employment provision for more than 200.
