Agenda Item No 02 :Proposal of M/s. Hilton Tobaccos Pvt. Ltd. for additional activity in their existing LoA- Reg.

M/s. Hilton Tobaccos Pvt. Ltd. has informed that they have been granted approval for manufacture of Filter Rods in the UAC meeting held on 11.04.2023, subject to the condition that the same shall be for captive consumption and no DTA sale shall be allowed.

The unit, while referring to the discussion held in the UAC meeting dated: 11.04.2023, has informed that during the discussed it was informed that they won't be allowed to sell the products into DTA, but they will be allowed for self-use (captive consumption), as well as for Export. But, in the approved minutes placed on the website of VSEZ, the proposal was approved for the manufacture and for captive consumption but permission was not granted for export of the same.

In this connection, the unit has informed that they intend to export the Filter Rods manufactured by them.

In this regard kind reference is invited to the extract of the minutes of the UAC meeting held on 11.04.2023 which is re-produced below: .

"The Approval committee after due deliberations, approved the proposal for inclusion of additional activity i.e. manufacture of filter rods for Cigarettes subject to the condition that the entire production of filter rods manufactured shall be for captive consumption and no DTA clearance is allowed". Accordingly, the approval was conveyed to the unit.
