VSEZ AGENDA – ANDHRA PRADESH

Agenda Item No.01:- Ratification of the Minutes of the meeting held on 10.02.2023.

Agenda Item No. 02 : Permission to install Airtel Mini Tower at M/s. Gland Pharma Ltd. Premises- Reg.

The Approval Committee after due deliberations, approved the proposal for installation of Airtel Mini Tower at M/s.Gland Pharma Limited Premises subject to the condition that the unit shall not avail any duty exemptions on the Airtel Mini Tower equipment. In case, if the unit intend to avail duty exemption on the equipment then the entire equipment shall be in the name of the unit for which a clear cut agreement/undertaking shall be entered between both the parties and a copy of the same shall be submitted to the DC office.

Agenda Item No.03: Proposal of M/s. Hilton Tobaccos Pvt. Ltd. for additional activity in their existing LoA-Reg.

The Approval Committee after due deliberations, approved the proposal for inclusion of additional activity i.e., manufacture of filter rods for Cigarettes subject to the condition that the entire production of filter rods manufactured shall be for captive consumption and no DTA clearance is allowed.

The committee also directed to send the proposal of M/s.Hilton Tobaccos Pvt. Limited to Ministry for necessary clarification relating to clearance of filter rods for Cigarettes in DTA by the unit.


