An undertaking in terms of Rule 22(2) of SEZ Rules and ground plan showing the place for storage of trading materials in their plant to maintain separate records, be submitted, subject to satisfaction of Customs officials. Also the unit may submit revised list of materials for activity along with ITC HS classification numbers against each, as the present list includes both consumables / finished goods.

In case of non receipt of the confirmation of demarcation from Specified Officer concerned with his clear recommendation within 10 days, the proposal shall be deemed to have been deferred and will be placed before next UAC for consideration.

Further, the unit vide letter dated 17.03.2022 informed to SO, APSEZ that the shed earmarked for trading activity was constructed in compliance to Minutes of the UAC held on 20.04.2021 and requested to visit the factory premises situated at Plot No. 36, APSEZ, Atchutapuram and requested to furnish the inspection report so as to take up the matter for next UAC meeting.

On 18.03.2022, the premises was inspected by SO, APSEZ with reference to the Minutes of the UAC meeting held on 20.04.2021 and found:

- 1. The shed proposed for trading activity is not entirely completed and it appears that the shed still required civil construction.
- 2. The proposed shed is yet to be secured with a gate.
- 3. The approach to the proposed shed is yet to be leveled to the appropriate height.
- 4. The drain situated on the approach to the proposed shed is yet to be covered with suitable cement slabs to sustain the weight of the proposed goods for trading activity.

The above observation were conveyed to the unit by SO, APSEZ vide letter dated 21.03.2022.

The unit vide letter dated 07.03.2023 referring to the SO, APSEZ letter 21.03.2022 informed to APSEZ that they have completed the construction of trading shed and the same is ready for their trading activities.

Hence, the SO, APSEZ was requested by this office letter dated 17.03.2023 whether the unit has completed all the above works observed in para 2 of your letter dated 21.03.2022 for taking further action in the matter.

The SO, APSEZ vide letter dated 17.03.2023 has confirmed that the unit has rectified the above observations 1 to 3 above. Regarding observation No. 4, he has stated that the premises is not covered by boundary walls on all sides. It is further observed that there is a small gap between the side wall of the shed and the tin sheeting that encompass the subject shed. The unit has been advised to secure the premises by properly covering all the said gaps to prevent any pilferage and report compliance.

The SO has further observed that the calibration of weight bridge which is situated in the manufacturing premises of the unit, which is proposed to be put into use for trading activity as well is yet to be revalidated by the Legal Metrology Dept. The unit has been advised to obtain the necessary calibration certificate from the legal Metrology Dept. and submit the same to DC's Office.

Now, the unit vide letter dated 12.04.2023, has informed with reference to the SO, APSEZ letter dated 17.03.2023 that they have completed the above 02 observations and furnished a copy of evidence of calibration certificate.

As directed, the SO APSEZ visited the site and findings with reference to Para 2 (iv) of their letter dated 17.03.2023 and submitted a report vide letter dated 25.05.2023 stating that the premises is now secured with boundary walls and all the gaps have been covered properly. It is further confirmed that the calibration of the weigh bridge situated in the manufacturing premises of the unit has been revalidated by the Legal Metrology Dept. and furnished a copy of Certificate issued in that regard.

In view of the above, the Unit was advised to submit a fresh proposal for inclusion of trading activity in the LoA vide this office letter dated 30.05.2023.
