Agenda Item No.01:- Ratification of the Minutes of the meeting held on 24.02.2023.

The minutes of the UAC meeting held on 24.02.2023 has been circulated to all the members of the UAC and also placed on the VSEZ website. No comments have been received from the members of UAC. The minutes are placed before UAC for ratification.

Agenda Item No.2 : Permission to install Airtel Mini Tower at M/s. Gland Pharma Ltd. Premises-Reg.

M/s. Gland Pharma Ltd vide letter(s) dated 16.11.2022 and 14.12.2022 has requested for permission to install Airtel Mini Tower on their unit's building.

The above proposal has been placed in the UAC meeting held on 10.01.2022 for consideration.

Wherein, the Approval Committee after due deliberations directed to VSEZ Authority to check the whether all the statutory approval have been obtained by the unit for installation of the Airtel Mini Tower and also directed the Specified Officer, VSEZ to check the agreement if any entered between parties and the ownership clause of the equipment and duly liabilities if any and process the request on file and inform the same to the members in the next UAC.

In this regard, VSEZ Authority vide letter dated 02.03.2023 has informed that upon examination the proposal, the same was not considered due to administrative and technical issues.

In this context the unit was advised to request Airtel network systems to approach VSEZ Authority for allotment of land or space on lease basis for installing the tower which can cater to the needs of the other units in the zone also.

The above position is placed before UAC for information.

Agenda Item No.02 : Proposal of M/s. Hilton Tobaccos Pvt. Ltd. for additional activity in their existing LoA-reg

M/s. Hilton Tobaccos Pvt. Ltd. vide letter dated 13.03.2023 has submitted a proposal for inclusion of additional activity i.e., manufacture of Filter Rods for Cigarettes in the LoA.

M/s. Hilton Tobaccos Pvt. Ltd. has been granted Letter of Approval on 14.06.2022 for manufacture of Cigarettes based on the Industrial License granted by the Ministry for export **subject to the condition that No DTA sale is permitted**. The unit has commenced operations on 22.02.2023. The LoA is valid upto 21.02.2028.

The unit has stated that as part of their expansion plans, they are planning to include additional activity i.e., manufacturing of Filter Rods for Cigarettes. which is an imported Raw Material in the cigarette manufacture. By manufacturing their own Filter Rods, they can reduce their input cost in a big way and create extra revenue by selling the excess Filter Rods to other Cigarette manufacturers

Agenda Item No. 02 : Request of M/s. Eisai Pharmaceuticals India Pvt. Ltd, a manufacturing unit in Ramky Pharma SEZ, Parawada, Visakhapatnam for installation of Solar Power Plant - Reg.

M/s. Eisai Pharmaceuticals India Pvt. Ltd a manufacturingunit in Ramky Pharma SEZ, Parawada, vide letter dated. 30.03.2023 has informed that they proposeto set up a solar power plant (ground mount) inside the factory premises for their captive consumption. The capacity of the proposed solar power plant is 3000 KW DC/ 2400 KW AC. The project shall be completed within financial year 2023-24.

In this regard, kind reference is invited to DoC's Power Guidelines O.M. No. K-43014(16)/8/2020-SEZ dated: 7th June 2021, allowing setting up of "non –conventional power plant with permission of UAC within the premises of an SEZ unit for the exclusive purpose of captive consumption of the unit with a condition that no tax/duty benefits stipulated under section 26 of SEZ Act, 2005 shall be available for setting up as well as operations and maintenance of such power plant. Such captive generating power plants shall comply with all rules, regulations and technical standards framed under the Electricity act, 2003 as amended from time to time. Captive generative power plants with capacity 500 KW and above has to be re-registered with Central Electricity Authority."

As per which, a unit may set up a non-conventional power plant with the approval of the Unit Approval Committee within the premises of the unit for the exclusive purpose of captive consumption subject to the condition that no tax/duty benefits stipulated under Section 26 of the SEZ Act,2005 shall be available for setting up as well as operations and maintenance of such power plant. Further, it is indicated that Captive Generative Power Plants with capacity 500 KWPH and above has to be re registered with Central Electricity Authority.

The unit has informed that theyhave registered with the Central Electricity Authority (CEA)-Registration No. 1400006814 and copy of the registration certificate is enclosed.

As per the power guidelines, the unit has informed that they will not avail any benefits for setting up of the Solar Power Plant.

The Authorised Officer, Ramky SEZ has informed the proposal has been verified and observed that the unit proposed to set up the Solar Power Plant on their own and engaged a contractor for supply, installation and testing.

Accordingly, the proposal is placed before UAC for consideration.
