AGENDA Item No. TS-184.14: Proposal of M/s. Divyasree Tech Park Contractors Pvt. Ltd, Co-Developer for M/s. Lanco Hills Technology Park Pvt. Limited, SEZ for IT/ITES at Manikonda Village, Rajendra Nagar Mandal, Ranga Reddy District, Telangana for setting up of Batching Plant in their SEZ.

The Co-Developer vide letter dated 28.3.2024 has stated that their

contractor viz., M/s. BCIM Engineering Pvt. Ltd, #11 B Wing, Divyasree Chambers, "O" Shaugnessy Road, Bangalore – 560 025 was accorded permission for setting up of a Batching Plant in their SEZ, in terms of Rule 41 (3) of SEZ Rules, 2006 vide VSEZ letter dated 29.5.2023 for a period upto 31.3.2024 or till the completion of construction of the building, whichever is earlier.

The Co-Developer has requested to extend their batching plant operation for P3 building for one more year.

The Specified Officer vide email dated 2.4.2024 has stated they have completed 5 basements, ground and seven floors so far out of the proposed five basements, Ground plus 21 floors. They would likely be completing the remaining floors by 31.3.2025. He has recommended for operation of Batching plant for one more year from 01.4.2024 to 31.3.2025.

In view of the above, the proposal of the Co-Developer for extension of time for operating Batching Plant for a period upto 31.3.2025 is placed before UAC for approval please.
